# Who is Eligible?

The Learning Ally Audiobook Solution is a proven supplemental resource designed to help struggling readers reach their potential. By offering students the use of human read audiobooks coupled with highlighted text, educators can help their K-12 students whether they are learning to read or reading to learn.

The Learning Ally Audiobook Solution is an important resource for students who demonstrate any of the following:

- 1. Struggles with decoding
- 2. Struggles with fluency
- 3. Struggles with reading comprehension

If you observe a student displaying any of these issues that prevent the student from keeping up with the students at their grade level, or from reading content at a level comparable to other students in the class, then they may qualify for Learning ally Audiobook Solution. An IEP or 504 is not required.

Additionally any student who is blind or visually impaired or who has a physical disability that prevents them from reading standard print is eligible.

### WHAT IS A READING DEFICIT?

A reading deficit is determined by a student's inability to keep up with content due to an impairment in at least one of the following areas:
